The Platform also allows Applicants to indicate an interest in the Platform and receive updates regarding Opportunities.

By using the Platform, you agree that, to the greatest extent permitted by law, Rural Aid shall have no liability whatsoever to you as a result of making your details available to any Organisation or Individual who may take part, avail themselves or be involved in the Platform or an Opportunity identified through the Platform.

You acknowledge that so far as you are linked with any Organisation or Individual as part of the Platform, you will make your own assessment to determine whether such Organisation or Individual and its requirements are appropriate for your needs and skills.
